Chairperson Lauderdale opened the public hearing. He gave an overview of the proposed amendments, noting that the Planning Commission had also had extensive discussion on the draft text at the December 18, 2017 meeting. Chairperson Lauderdale reiterated that he was pleased with the simple and straight forward nature of the proposed ordinance provisions.

Harvey confirmed that the draft text dated January 8, 2018 incorporates the modification to Subsection B. discussed by the Planning Commission in December.

Fry questioned if any changes in the laws/rules had occurred at the State level since the December 18, 2017 Planning Commission discussion. Attorney Thall responded that that there have been no changes. He added that Ross Township is ahead in the process compared to many communities in this area and that this ordinance language will likely be used as a model ordinance.

Kyle Barker expressed his appreciation for the change made to Subsection B. He added that 'the beauty of this ordinance is in the simplicity of the approach'. No further public comment was offered on the matter. Chairperson Lauderdale stated that no written correspondence had been received regarding the proposed amendment. He then closed the public comment portion of the public hearing.

Fry <u>moved</u> to recommend approval by the Township Board of the proposed amendments to the Ross Township Zoning Ordinance as set forth in the January 8, 2018 Public Hearing Notice. Snyder <u>seconded</u> the motion. The motion <u>carried</u> unanimously.
