Approve the purchase of the Ross Township parking stops and banner for Ross Township Park. The projected cost is \$133 for the banner. A motion to approve the banner cost of \$133 was presented by Trustee Langshaw, supported by Trustee Harmon and passed unanimously.

Ross Township Fire Protection Millage renewal. This renewal request can be moved to the August election if needed. This is due to the Corona virus outbreak and subsequent stay at

home orders by the Governor. If the KRESA ballot request stays on the ballot we will keep our request for the May 5, 2020 election. If KRESA withdraws their request we will also withdraw our Township request. A Board meeting is tentatively scheduled for Friday march 20th at 9:00am to discuss and remove our ballot request if needed.
