NOTICE OF PUBLIC HEARINGS AND MEETING OF

**TO: THE RESIDENTS AND PROPERTY OWNERS OF THE TOWNSHIP OF ROSS,
KALAMAZOO COUNTY, MICHIGAN AND ANY OTHER INTERESTED PERSONS:**

PLEASE TAKE NOTICE that the Ross Township Zoning Board of Appeals has scheduled public hearings to be held at a regular meeting on **January 6, 2021 at 5:30 P.M.** at the Ross Township Hall located at 12086 M-89 within the Township of Ross, Kalamazoo County, Michigan. If however the Zoning Board of Appeals is prohibited by law from holding the meeting in person due to COVID-19 restrictions then the meeting shall be held electronically via Zoom video/and teleconference. If an electronic meeting is required then such notice of the electronic meeting with participation information will be posted to the Township website and on the Township Hall door at least 18 hours before the meeting.

The items to be considered at this meeting include, in brief, the following:

1. Public hearing on the Application for Variance of:
James Dally
3056 Oakdale Drive
Subject Parcel Property Tax Identification Numbers: 3904-07-430-114 and 3904-07-430-116 located in the R-1 Low Density Residential Zoning District within Ross Township.

The Applicant is requesting a variance to Section 18.6(c) of the Ross Township Zoning Ordinance to construct a five foot high front yard fence and gate where the Zoning Ordinance permits a four foot high fence.

2. Public Hearing on Zoning Ordinance Interpretation Request from the Ross Township Zoning Administrator regarding the fence definition in Section 2.2 of the Ross Township Zoning Ordinance to determine whether it includes live vegetation as a fence.
3. Such other matters as may properly come before the Board

The Ross Township Zoning Ordinance/Map and Land Use Plan, the legal description of the property involved with the above variance, the application with supporting documents, and the request for interpretation may be examined by contacting the Ross Township Clerk at the Township Hall during regular business hours on regular business days maintained by the Township Offices from and after the publication of this Notice, and may also be examined at the meeting.

Written comments regarding the above referenced matter may be submitted at the Township Hall prior to the meeting, and may further be submitted to the Zoning Board of Appeals at the meeting.

Ross Township will provide necessary reasonable auxiliary aids and services at the meeting to individuals with disabilities such as signers for the hearing impaired and audiotapes of printed

materials being considered, upon three (3) days' notice to the Township. Individuals with disabilities requiring auxiliary aids or services should contact the Township Clerk as designated below.
