## CITIZEN COMMENT:

Bob Cook, of 2754 Burlington Drive, indicated that if his neighbor planted a row of trees similar to the Carr property he would lose 80% of his view of the lake. He indicated that if the Township cannot protect the viewshed then a big problem exists. Public comment was closed at 4:06 p.m.

#### MEDICAL MARIHUANA CAREGIVERS ORDINANCE:

The Board engaged Township Attorney Thall in detailed discussion regarding the propsed Medical Marihuana Caregivers Zoning Ordinance amendment. Motion was made by Trustee Harmon to approve the Medical Marihuana Caregivers Ordinance amendment as written. Trustee Sulka seconded the motion. In discussion of the motion the Board addressed with Attorney Thall existing medical marihuana caregivers in the Township and the ability of the Township to regulate such operations. Attorney Thall addressed that the Zoning Ordinance amendment is subject to grandfathering concepts but that police power ordinances could still be enforced regarding nuisance violations. Further, he stated that the State Cannabis Regulatory Agency would have authority to enforce any violations of a caregiver's permit from the state. Finally, it

was noted that the Township Board will need to adopt a fee resolution setting the fee for a caregivers home occupation permit.
