### NEW BUSINESS

1. Public Hearing – Zoning Ordinance Amendment (Site Condominiums)

The next matter to come before the Planning Commission was the public hearing on the proposed amendments of Section 2.2 – Definitions of Terms and Section 21.2 – Uses Subject to Site Plan Review related to the regulation of site condominiums.

Chairperson Lauderdale opened the public hearing.

Chairperson Lauderdale provided an overview of the proposed text, referencing the informational memo and draft text provided at the October 24, 2022 meeting and the discussions of the Planning Commission on same in October and November.

Attorney Thall concurred that the proposed addition of certain definitions and the amendment of Section 21.2 adding site condominium projects will appropriately subject them to the site plan review process and address them similarly to plats/subdivisions.

In response to questions from Sager, Harvey clarified the distinctions between a multiple family development and a site condominium project. The review process applicable to plats and site condominium projects was also detailed.

No public comment was offered on the matter and the public comment portion of the public hearing was closed.

Bekes <u>moved</u> to recommend approval by the Township Board of the proposed amendments to Section 2.2 and 21.2 regarding the regulation of site condominiums. Moore <u>seconded</u> the motion. The motion <u>carried unanimously</u>.
