PRE-MARCH BOARD OF REVIEW APPEALS/DISPUTES:

- FOLLOWING THE MAILING OF ASSESSMENT NOTICES EACH YEAR IN FEBRUARY, TAXPAYERS MAY REACH THE ASSESSOR VIA PHONE AND EMAIL ABOVE WITH ANY QUESTIONS OR CONCERNS THEY MAY HAVE.
- TAXPAYERS ARE ENCOURAGED TO MAKE AN APPOINTMENT TO MEET WITH THE ASSESSOR IN PERSON TO DISCUSS CONCERNS REGARDING THEIR ASSESSMENT, THESE APPOINTMENTS CAN BE MADE UP TO THE FIRST MONDAY IN MARCH.
- FOLLOWING THIS THE TAXPAYER MAY FURTHER REQUEST AN APPOINTMENT TO APPEAR AT THE MARCH BOARD
 OF REVIEW IF HE/SHE WISHES. A MEETING WITH THE ASSESSOR IS NOT REQUIRED BEFORE SPEAKING WITH THE
 MARCH BOARD OF REVIEW.
