Overview/Updates from Fire Chief/Officers/Firefighters:

Grass Truck back and 100% complete. 10K grant is in process, although not received yet – possibly in next 4-6 weeks. Runs slightly up from last month – incident report **attached** (D. Bogema) – New Airbottle Fillers needed (B.Shirley). This must be taken to the Ross Township Board for additional funds at this point; all Ross Township AARPA funds spent/accounted for year to date. Bi-Laws:

Amendment made to the Interlocal Fire Department Agreement (Term of Office of Fire Board Members, page 2) to rotate the terms of the Fire Board Members on alternate years, one member from each entity (Ross Township and the Village of Augusta) will have elections on alternate years, one member from each entity on an even year, and one member from each entity on an odd year (staggered terms) for amendment. This Amendment is at the Township Attorney's office for drafting language. – Moved by D. Langshaw, Seconded M. Waldlorf (Approved, All Ayes, 0 opposed)

Also noted, Fire Chief Annual Evaluation, per bi-laws, has fallen by the wayside, and must resume per bi-laws. (D. Langshaw)

Review of the facility repairs, and who is responsible for them to be clarified (D. Langshaw, D. Bogema). Provisions in the Agreement regarding millage funds for upkeep of buildings to be reviewed. V. Silkworth asked about the language noted in the Millage, on how funds are allocated.
