**Ross Augusta Fire Department** – Chief Doug Bogema, the fire department had 395 calls last year. Had 69 calls in both January & February, and 100 so far this month.

Received a matching grant for \$4,600, for life rescue suits, utility trailer and packs for grass fires.

The firefighters had ice rescue training the last couple of weeks.

**Ross Police Department** – Chief Martin Brown, quiet this month.

Did have to help with an Amazon driver being hit, he is recovering well.

Received a grant from Gull Lake Water Quality group. This money will go to hiring a Marine Patrol, 2 parttime deputies to help with lake patrol starting Memorial Day weekend.

**Kalamazoo County Sheriff's Office Liaison** – Lt. Jim Harrison introduced himself to the Board.

**Supervisor Hutchings** – meet with RCKC & MDOT concerning G Ave and M 96 intersection. They will be removing obstructions to seeing the curve, remove items that cars run into, and may add rumble sticks. She suggested to MDOT that they look at how M 89 comes into Michigan Ave, they had never seen the intersection. The problem with straightening G Ave is there is water on the southside of the road.
