To: The residents and property owners of Ross Township, Kalamazoo County, Michigan, and all other interested persons.

Please take notice that the Ross Township Board will hold a special meeting on May 20, 2025, at 5:00 p.m. at the Ross Township Hall located at 12086 M-89, Richland Michigan 49083.

At such time, the Township Board shall hold a public hearing regarding whether recreational boating and surface water use problems exist within the Southwest Bay area of Gull Lake, adjacent to the Gull Creek/Dam, with regards to boat speed and wake. Further, the hearing will consider whether the Township Board should request, by resolution, that the Michigan Department of Natural Resources hold a public hearing to inquire into the need for special controls on the Southwest Bay area of Gull Lake and assist in establishing a special local watercraft control ordinance. Following the public hearing the Township Board may take action regarding this matter.

Ross Township will provide necessary reasonable auxiliary aids and services, such as signers for the hearing impaired and audio recordings of printed materials being considered at the hearing, to individuals with disabilities upon reasonable notice to the Ross Township Clerk.
